- The Plot will be allotted under Gandamalla Village, Turakapally Mandal, Yadadri-Bhuvanagiri District of Telangana (under DTCP purview).
- To join the scheme, a member should pay Rs. 2,500/- as Appl. Regn. (For a unit of 150 Sq. Yds.) along with the Enrollment Amount.
- The minimum Plot area allotted would be 150 Sq. Yds. more than that will be charged at the prevailing price.
- 60 days (OUTRIGHT) Scheme: Members who pay the Total Plot Cost within 60 days from DOA will get a discount of Rs.1,00,000 and additional discount of 15% on balance plot cost. The Total Discount is Rs. 2,31,250/- (Rs. 1,00,000 + Rs.1,31,250/-).
- 3 To 10 Months Scheme: Members who pay the Total Plot Cost within 10 months from DOA will get a discount of Rs. 1,00,000/- and additional discount of 12% on balance plot cost. The Total Discount is Rs. 1,86,736/- (Rs. 1,00,000 + Rs. 86,736)

- 12. If a member reserves a Plot and defaults in payments, the Company has right to cancel his/her Plot without any prior Notice. If the payment is regularized later, another Plot has to be selected from the available vacant plots at the time. Plot cost will be recalculated as per the prevailing prices & not on the price booked.
- No Cancellation of Membership is entertained / accepted by the Company.
- 14. Delay charges of Rs. 2,000/- per month will have to be paid for each overdue installment. If the installments are not paid for two months in succession, Pass Book will be treated DEFAULT and Clause No. 12 will be applicable.
- 15. Change of name or Transfer of Membership, to some other Member, who is identified by the existing Member will be according to Company rules and regulations and will attract transfer fee of Rs. 10,000/- per 150 sq. yd. Plot.
- 16. The Layout would be fully developed as per the norms. All the development will be completed only by the end of the Scheme period.
- Registration / Sale Agreement Charges are to be borne by the Members as fixed by the Company from time to time.
- 18. Those who make the payment through Credit / Debit Card Service Charges of the Bank will be borne by the member.
