## **MUTUALLY AGREED TERMS & CONDITIONS**

- 1. The plot will be allotted under Rustapur and Jangampally villages, Turakapally & Yadagirigutta Mandal, Yadadri Bhongir Dist. (under DTCP purview).
- 2. To join the scheme, a member should pay Rs. 1000/- as application registration. (for a unit of 150 sq. yds.) along with the enrolment amount
- 3. The minimum plot area allotted would be 150 sq. yds . In excess to 150 sq. yds as per approval, price will be charged at the prevailing rate.
- 4. All the north east corner plots will be charged @ Rs. 200/per sq. yd. All the corner plots will be charged @ Rs. 100/per sq. yd. All the plots facing 60' road will be charged @
  Rs. 200/- per sq. yd. each side. These extra charges must be
  paid in advance along with plot reservation amount.
- 5. The Management reserves the right to alter the layout partly or fully. Accordingly final plot will be allotted as per DTCP layout.
- 6. If a member reserves a plot and defaults in payments, the Company has the right to cancel his / her plot without any prior notice. If the payment is regularized later, another plot has to be selected from the vacant plots at that time. Plot cost will be recalculated as per the prevailing price & not on the price booked.
- 7. No cancellation of membership is entertained / accepted by the Company.
- 8. Delay charges of Rs. 2,000/- per month will have to be paid for each overdue installment. If the installments are not paid for two months in succession, pass book will be treated as default and clause no. 6 will be applicable.
- 9. Change of name or transfer of membership to some other member, who is identified by existing member will attract transfer fee of Rs. 5,000/- per 150 sq. yds. plot
- 10. The layout would be fully developed as per the norms. All the development will be completed only by the end of the project schedule.
- 11. Registration / sale agreement charges are to be borne by the members as fixed by the Company from time to time.
- 12. Those who make the payment through credit /debit card, service charges of the Bank will be borne by the customer.
- 13. The Company will not be responsible for any loss caused by the act of nature or act of legislation.
- 14. Management reserves the right to admit or reject any membership.
- 15. Registration of plots will be done after total plot cost received and getting layout approval.
- 16. All legal matters are subject to jurisdiction of Secunderbad court only.
